# Curriculum

# Primary Activities

## **Club Meetings**

A weekly meeting on Tuesday after school. Accentuated by guest speakers, field trips and projects.

# **Paid Internships**

Students are paired with an alumnus entrepreneur and work for four weeks. The club pays each student \$1,000 for the four-week period.

# Ignatius Shark Tank

Alumni judges come back to campus to judge our students and their pitches. Between \$1,000 and \$1,500 given to students to accelerate their business growth.



# Campus-Wide Stock Contest

Twice a year, a semester-long stock competition allows students to play the market in our *\$100,000 Challenge*. Students play for extra credit and cash prizes.

# Strategic Community Partnerships

Students serve as ambassadors and aids for other incubator organizations like Social Venture Partners and Sea Change. Distinguished alumni often volunteer for these activities.
