Since 1886, Saint Ignatius High School has been dedicated to forming young men of faith by inspiring them to know, love and serve Jesus Christ. The generosity of the Saint Ignatius community plays a critical role in continuing this mission and there are a number of ways to participate.

The Annual Fund is a yearly campaign seeking gifts that help all areas of the school, most importantly by providing tuition assistance.
